#### **Urge New Jersey Leaders to Restore the Affordable Housing Trust Fund**

The NJ budget diverted \$125 million from the Affordable Housing Trust Fund (AHTF), a critical resource for building affordable housing for low income and very low-income residents. With a shortfall of nearly 290,000 affordable homes in NJ, restoring this fund needs to be a top priority. Your voice has already made an impact: **\$45 million** was restored to the Trust Fund as a result of our advocacy, but more action is needed. **Contact Governor Murphy and your state legislators** to urge them to restore the AHTF, using revenue from the new mansion tax.

### Stop the Dramatic Cuts and Federal Weaponization of CoC Funding, Putting Over 170,000 People at Risk of Homelessness

In a change expected to put more than 170,000 Americans at risk of experiencing homelessness, Politico reported this week that HUD is planning to make dramatic cuts to the FY25 Continuum of Care (CoC) Notice of Funding Opportunity (NOFO). These include capping CoC funding for permanent supportive housing programs at 30%, compared with 87% of CoC funds for supportive housing now, and penalizing communities not aligned with the administration's partisan agenda. Urge Congress to not politicize life-saving homeless services funding and hold HUD accountable to their promised 2-year funding cycle!

**Top tips for federally-funded organizations** to ensure the least amount of potential impact on people experiencing homelessness.

Confirm access to e-snaps and eLOCCS for all who need it.

Review any grant-associated deadlines (not associated with the CoC competition).

Be patient with federal offices if they are slow to respond.

**Check in with program participants** and come up with a plan for how to support them in accessing public benefits.

### <u>Time to Raise Federal Poverty Line,</u> <u>Dozens of Lawmakers Say</u>

New Jersey lawmakers have passed bill AR131, a resolution urging the federal government to raise the outdated federal poverty line so more families can qualify for critical programs like Medicaid, SNAP, and TANF. Sponsors argue that the current formula, created in the 1960s and based only on food costs, fails to reflect today's high expenses for housing, childcare, and healthcare, leaving millions of struggling households ineligible for aid. While symbolic, the measure highlights the growing push to modernize poverty guidelines and address the "benefits cliff" faced by low-wage workers.



### How Rent Control Works in New Jersey\_

More than one-third of New Jersey households rent their homes, but there's no statewide rent control system—each municipality sets its own rules. As of 2025, only about 1 in 5 towns have rent control ordinances, mostly in the state's largest counties, and enforcement varies widely. Tenants can confirm whether their unit is covered by local rent control by checking municipal ordinances, contacting rent boards or clerks, and filing complaints if landlords impose unlawful increases.



# Housing and Community Development Network Launches Action Fund to Advance Housing Justice

The Housing and Community **Development Network of New** Jersey has launched the **Housing** and Community Development **Network Action Fund (HCDN Action Fund)**, a 501(c)(4) focused on advancing housing justice through lobbying, community education, and political engagement. The Fund will advocate for policies that prioritize housing as a human right, support community development corporations, and revitalize neighborhoods across New Jersey. By directly engaging with policymakers and promoting leaders who share these values, the Action Fund aims to build stronger, more affordable communities statewide.



## Controversial Homelessness Policy Tabled, As Haddonfield Considers New Paths

Haddonfield officials have tabled a controversial ordinance that would have criminalized sleeping outside and imposed fines or jail time on unhoused residents. Following strong public outcry and alternative proposals, the borough is now considering hiring a social worker to work with police and local organizations to provide support rather than punishment. While the ordinance could be revisited, commissioners signaled that pursuing compassionate, community-based solutions may be the more effective path forward.



### Over 15K Households Have Applied for Section 8 Waitlist in Newark

More than 15,000 households have already applied for Newark's Section 8 Housing Choice Voucher waitlist just two weeks after it opened, highlighting the city's urgent demand for affordable housing. It's the first time the waitlist has been opened



### New Jersey Families Benefit from PSEG Foundation's Support of HomeFront

HomeFront, with support from the PSEG Foundation, is making a significant impact for families in New Jersey by providing shelter, meals, housing assistance and since 2013, and applicants will be selected through a lottery system. To qualify, households must earn less than 80% of the area median income, with priority given to those earning significantly less.

children's programs. In 2024 alone, the organization supported more than 30,000 individuals, distributed over 1.8 million meals and 1.1 million diapers, enrolled 139 children in enrichment programs, and more.

## Westfield Honored for Efforts Addressing Homelessness, Affordable Housing

Westfield, NJ has been recognized with the 2025 Municipal Award from the Supportive Housing Association of New Jersey for its leadership in advancing supportive housing. The town was honored for programs like its Affordability



Assistance initiative, emergency preparedness in affordable buildings, and community engagement, as well as for developing 22 permanent housing units for homeless and atrisk veterans in partnership with local veterans' organizations. This project highlights how municipalities can play a key role in expanding housing and services for vulnerable populations.

### Trump Admin Looks at Deep Cuts to Homelessness Housing Program

The Trump administration is preparing major cuts to HUD's Continuum of Care program, reducing funding for permanent housing and redirecting it toward transitional housing with work or service requirements. This shift would lower permanent housing support from \$3.3 billion to about \$1.1 billion, potentially putting more than 170,000 people, including families and people with disabilities, at risk of returning to shelters or the streets. Critics warn the change undermines proven housing solutions, may violate federal law, and will leave rural communities especially vulnerable.



2028 Olympics: Fears of Mass Displacement and Homeless Sweeps as Trump Threat Looms

With the 2028 Olympics on the horizon, fears are growing that Los Angeles will once again push unhoused communities out of sight, echoing the harsh crackdowns of the 1984 Games. Mayor Karen Bass has pledged a "housing first" approach, but mounting pressure from Trump and Newsom has advocates bracing for sweeps and displacement. As the city faces a worsening housing crisis, many warn the Olympics could become a flashpoint for deepening inequality unless bold, humane action is taken.



The Massive Stakes of The Big Federal Housing Bill Explained

The U.S. housing crisis is worsened by fragmented layers of government, where local opposition often blocks new development despite broader regional benefits. While some states like Oregon and California have stepped in to override restrictive zoning, large-scale reform remains difficult. The bipartisan ROAD to Housing Act offers modest federal steps — such as model zoning codes and financial incentives for cities that expand housing supply — which some experts believe



Trump's Push to Institutionalize
Homeless Americans Offers Quick
Fix and Sparks Fear

President Trump is pushing a plan to expand civil commitment, which would force many homeless people into long-term institutional treatment for addiction and mental illness. Supporters argue it could restore public order, but critics warn it threatens civil liberties, is prohibitively expensive, and lacks the treatment capacity to succeed. Experts emphasize that affordable housing and voluntary care are more effective and less costly than mass institutionalization.



Millions Could Lose Housing Aid
Under Trump Plan

The Trump administration's new executive order rolls back support for the "housing first" model, instead promoting punitive measures like mandatory treatment, institutionalization, and criminalization of homelessness—despite strong evidence showing housing-first programs improve stability, reduce costs, and save lives. Advocates warn this shift will endanger vulnerable populations, including domestic violence survivors, youth at risk of trafficking, and people with severe mental illness, by denying them access to stable housing without preconditions. As one

could evolve into transformative "Right-to-Build Zones" that make it easier to construct new homes where they're most needed.

To Get People off The Street, He Pays for a One-Way Ticket Home

An activist in Santa Monica launched a small hotline program that offers unhoused people free bus or plane tickets to reunite with family, operating as a quicker and cheaper alternative to traditional housing or rehab programs. Using an A.I. chatbot to intake calls, the effort has already sent people from Los Angeles back to places like Philadelphia, Idaho, and North Carolina, though often without long-term supports in place. The initiative reflects a growing trend in West Coast cities to reduce visible homelessness through relocation, raising both hope for reconnection and concerns about whether it truly solves the crisis.



Opinion: Preventing Youth
Homelessness Before It Starts

A mother who experienced homelessness with her two young children shared how navigating New York City's system left her feeling invisible and unsupported until she connected with Henry Street Settlement and Point Source Youth. As a youth consultant, she helped design the Targeted Housing Assistance Program, which provides direct cash aid and personalized housing plans to young people in crisis, preventing them from entering the shelter system. The pilot, now in eight cities, has shown strong results with 90% of participants stably housed within 30 days, offering hope for scalable, compassionate solutions to youth homelessness.

## Bipartisan RESIDE Act Aims to Convert Vacant Spaces into Housing

The bipartisan RESIDE Act would launch a pilot grant program to convert vacant offices, malls, motels, and other unused buildings into affordable housing, helping address shortages in major U.S. cities.

Advocates argue that without affordable housing, it's nearly impossible for people to overcome challenges like unemployment, addiction, or mental health crises, and that evidence shows housing is both more effective and less costly than punitive approaches. Local leaders in Michigan and beyond continue to push for long-term housing solutions, harm reduction, and comprehensive support services, underscoring that homelessness is best addressed with compassion and stable housing rather than punishment.

Lawmakers describe it as a cost-neutral way to revive underused properties, boost housing supply, and support homeownership. If enacted, HUD would oversee the program through its HOME initiative, prioritizing communities with fewer regulatory barriers to conversions.



## Homelessness Is Dropping in California Counties but Funding Cuts Could Derail That Progress

Homelessness among older adults is rising sharply, with more than 138,000 seniors experiencing it on a single night in 2023. Advocates warn this "emerging crisis" is fueled by rising rents, cuts to safety net programs like Medicaid and SNAP, and the loss of federal job training programs for older people, leaving many at risk of losing stable housing late in life. Programs like PACE, which aim to help elders remain in their homes, now face the challenge of serving clients who have no home to return to.



## The Low-Income Housing Tax Credit Does Not Address The Root of America's Housing Challenges

The Low-Income Housing Tax Credit (LIHTC) is the largest federal program supporting affordable housing, costing about \$14.4 billion annually in tax breaks to developers and creating 3.7 million units since 1987. While it has helped place affordable homes in location-efficient areas and improve neighborhood stability, critics argue it is overly complex, costly, and inefficient, often failing to expand the overall housing stock. Policymakers are now questioning whether simpler alternatives—like zoning reforms to allow more medium-density housing—could address the housing shortage more effectively and at lower cost
